Date, Time and Venue

The 2017 Miss Gay Georgia USofA, Miss Gay Georgia USofA Classic, and Miss Gay Georgia USofA At Large Pageants will be Sunday, March 26, at 7:30 p.m., at The Jungle in Atlanta, GA.

Contestants must arrive at The Jungle by noon (12 p.m.) on the day of the pageant for registration. Immediately following registration and rehearsal will be Personal Interview Competition. Please bring your Personal Interview outfit with you to The Jungle at noon. There will be appropriate changing areas for contestants.

Doors at The Jungle will open to the public at 6:30 p.m.

All contestants **must** arrive to the pageant by 7 p.m. Administrative points may be deducted from your total score if you do not arrive on time. You may arrive early to get ready.

Tickets to the pageant are \$20 each (\$15 in advance).

Entry Fee

The entry fee for Miss Gay Georgia USofA is \$125.

The entry fee for Miss Gay Georgia USofA Classic and At Large is \$100.

If you register by March 1, you may deduct \$25 from your entry fee. Contact Jeremy (jeremyburnette@gmail.com) or Darryl Kent (darryl-usofa@att.net) for more information or to register early. There is no refund of early registration fees. You may pay by credit card or PayPal.

All other entry fees must be paid at registration.

*Winners and 1st Runners-Up to Miss Georgia USofA, Classic, At Large **MUST** sign a contract the night of the pageant with Georgia USofA Pageants or they will not receive any of the prizes and will forfeit their placements.

Rules and Regulations

Please read the following rules and regulations carefully. Georgia USofA Pageants will strictly follow these rules. Therefore, it is important that you read the rules and regulations thoroughly. There will be no exceptions.

1. Contestants for Miss Gay Georgia USofA, Miss Gay Georgia USofA Classic, and Miss Georgia USofA At Large must be born males.
2. Contestants for Miss Georgia USofA At Large must weigh 200 lbs. or more. Contestants will be weighed at registration.
3. Contestants must be 21 years old by the National Pageant to enter Miss Gay Georgia USofA or Miss Gay Georgia USofA At Large. Contestants must be 40 years old by the National Pageant to enter Miss Gay Georgia USofA Classic. Contestants will need to provide valid, unexpired identification at registration.
4. Judging will be on a total point accumulated system. Score sheets will be provided by USofA Pageants. Ties will be broken by the contestant with the higher score in the Talent category. If there is still a tie, Interview will break the tie.
5. Contestants will be judged in the following categories: Personal Interview, Talent, and Evening Gown.
6. Talent will be limited to seven (7) minutes. Prop setup and teardown will be limited to five (5) minutes total. Talents over seven (7) minutes will have administrative points deducted. Deductions will be five points per minute or partial minute for all minutes over the seven minutes allowed.
7. Any type of talent presentation is acceptable except those that may cause injury to the audience or any other person. No glitter, fire, or water may be used in any Talent presentation.
8. The use or dispensing of illegal drugs or marijuana will not be tolerated while a contestant is participating in a Georgia USofA or USofA Pageant event. Immediate disqualification will result for those who break this rule.

9. Once interview begins, any contestant that is not at the appointed place at the appointed time will lose administrative points. Deductions will be five points per violation. If a contestant arrives to compete in the pageant after the Interview Competition has begun, five (5) administrative points will be deducted for every thirty minutes of tardiness (5 points for 1 to 30 minutes late, 10 points for 31 to 60 minutes late, and so on).
10. Any contestant, contestant's dancer(s), helper(s), etc. who is caught in the act of stealing or tampering with another person's property will be disqualified and removed from The Jungle.
11. USofA Pageants does not discriminate against entertainers with silicone and/or hormones. The use of silicone and/or hormones *will not be considered* by any judge scoring the contestants. Nudity and pasties will not be allowed by anyone (contestant, dancers, former titleholder, entertainment, etc.) in any portion of any preliminary or final night competition.
12. Once a contestant has placed 1st Runner-Up in a USofA Preliminary Pageant they may not continue to compete in that system. They must go to the national pageant with that placement.
13. USofA Pageants and Georgia USofA Pageants reserve the right to make any decision concerning any matter not covered by these Rules and Regulations.
14. Any contestant that qualifies for Nationals at Miss Gay Georgia USofA, Miss Gay Georgia USofA Classic, or Miss Georgia USofA At Large and fails to attend will be barred from competing in, entertaining, judging or attending any USofA Pageants event until they have paid back their promoter all prize monies and paid a \$125 fine to the National Promoter.
15. Winners and 1st Runners-Up to Miss Gay Georgia USofA, Miss Gay Georgia USofA Classic, and Miss Georgia USofA At Large **MUST** sign a contract the night of the pageant with Georgia USofA Pageants or they will not receive any of the prizes and will forfeit their placements.

Categories

Personal Interview

The purpose of the Personal Interview in the USofA System is to allow the Judges some insight into the character of each contestant. During the interview the Judges are also afforded the opportunity to evaluate each contestant's basic qualities, such as intelligence, ability to communicate, attitude, and composure, etc. The judges may also gather information about a contestant's professional or personal life.

The basic nature of the Personal Interview is intended to be casual and relaxed. The suggested attire for the Personal Interview is business or business casual. However, each contestant should select clothing in which she or he feels at ease, whether it is male or female attire.

Presentation

There will be no presentation of contestants at the 2017 Miss Gay Georgia USofA, Classic, and At Large Pageants. This allows the contestants to focus their time and resources on the judged categories.

Evening Gown

Evening Gown competition is the first time the judges and audience will see each contestant on stage. Evening Gown competition begins with each contestant modeling her gown for the judges. This is a free modeling period and the contestant can use all of the stage area. During the contestant's modeling, the emcee will read the gown's designer, accessory designer, makeup artist, hair stylist, and sponsors.

One of the hallmarks of the USofA system is comparative modeling in Evening Gown competition. All of the contestants will be brought back onto the stage in one line. This gives the judges the opportunity to comparatively score the contestants.

USofA Pageantry revised the Evening Gown category description a few years ago. In fact, the national pageant owner and directors adopted the evening gown description written by Jeremy, Miss Georgia USofA Pageants owner. Please read, review, and follow this

description thoughtfully:

Evening gowns may be of any color or style. They must, however, be full length. The gown must fit well, the contestant must model it elegantly, and all of the elements (hair, make-up, accessories, shoes, and gown) must come together for an overall look that makes the contestant look her very best. The Miss Gay USofA Evening Gown competition has traditionally rewarded contestants who bring a unique combination of evening gown, hair, make-up, accessories, modeling, and poise to the stage. **That has not changed.** The USofA System has often rewarded gowns that include lots of rhinestones, beading, etc., as well as hair and accessories that may be described as "*high drag*." These are still appropriate for Evening Gown Competition in the Miss Gay USofA and At Large Pageants.

While couture gowns are also appropriate for the USofA Evening Gown category, this is **not** creative evening wear competition, and gowns that are costumes should be avoided. We also discourage gowns that are so heavily embellished that the contestant cannot model them elegantly. Also, judges are asked to educate themselves about current fashion, and contestants should be aware that a gown, though beautiful, may be outdated and therefore not score as well as it might otherwise. Further, a gown with few or even no embellishments (stones, etc.) can score just as well as a fully embellished gown if the overall look (make-up, hair, accessories, shoes, poise, fit, modeling) make the contestant look her very best.

Talent

The third and final category of competition is Talent. Talent may be any type of entertainment presentation as long as it does not create the danger of injury to either the contestant or anyone else. Talent Presentations are limited to seven (7) minutes in length. Prop set-up and knockdown time is limited to five (5) minutes. There is no restriction on the number of persons who may be involved in the talent presentation. No fire, water, or loose glitter is allowed by any contestant in this category of competition. Talent music must be on a high-quality CD.

Judges

The judges for Miss Gay Georgia USofA, Miss Gay Georgia USofA Classic, and Miss Gay Georgia USofA At Large 2017 were not confirmed as of the date of the distribution of this handbook (2/2/17). We will announce judges on Facebook once confirmed.
